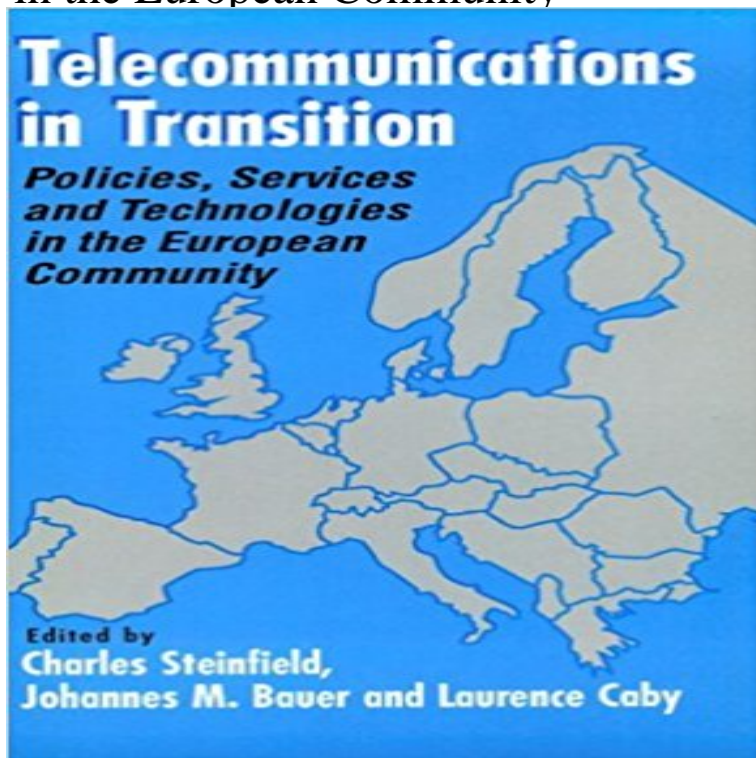


Telecommunications in Transition: Policies, Services and Technologies in the European Community
