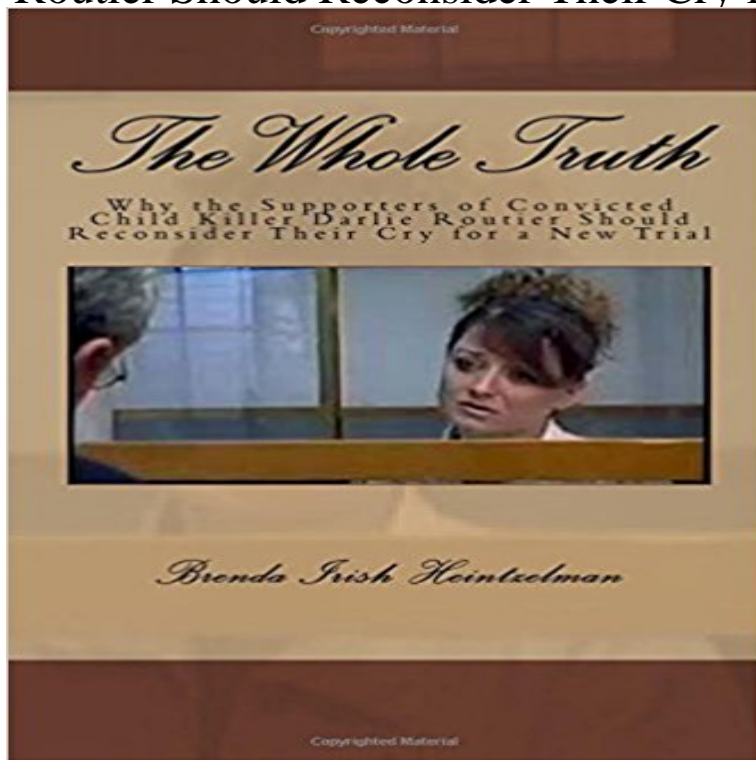


The Whole Truth: Why the Supporters of Convicted Child Killer Darlie Routier Should Reconsider Their Cry for a New Trial

Her supporters, few but vocal, have been holding fundraisers for Darlie since the day her sons were murdered. When Jodi Arias was convicted of murder she was ordered to not profit in any way by the notoriety of her case. So why is it that Darlie Routier is allowed to have fundraisers held in her name for over twenty years? The generous donors who continue to funnel money based on promises that soon, very soon, she will get a new trial, deserve to know the truth. And more importantly, Darlies only surviving son deserves to know in his heart that his mother was not treated unfairly by the criminal justice system.
